Eight grantees announced for national innovation program: Innovation Labs for the Performing Arts, Arts Development Agencies

Participating organizations from across the U.S. will design and prototype innovation initiatives and tackle field-wide challenges

July 30, 2014 — Eight organizations have been selected to participate in two new rounds of the *Innovation Lab*, an intensive program in organizational innovation for arts groups. Designed and managed by EmcArts, the *Innovation Labs* are funded by a generous \$1.58 million grant from the Doris Duke Charitable Foundation.

The four grantees in Round 9 of the *Innovation Lab for the Performing Arts* are **In the Heart of the Beast Puppet & Mask Theatre, Intermedia Arts, Pillsbury House + Theatre, and The Public Theater.**

The four grantees in Round 2 of the *Innovation Lab for Arts Development Agencies* are the **Association of Performing Arts Presenters (APAP)**, the National Association of Latino Arts and Cultures (NALAC), the Network of Ensemble Theaters (NET), and Urban Bush Women.

These organizations will design and prototype new ideas and launch real-life projects that address complex challenges facing their organizations and the arts and culture field at large. They will participate in the *Innovation Lab*'s extended framework of individual coaching and group facilitation, securing significant time and space away from the regular workplace to question, rethink, plan, and learn to innovate effectively. In addition, they will receive much-needed change capital to underwrite repeated experimentation. These two *Innovation Lab* cohorts will begin their work in July 2014, working with EmcArts' expert facilitators through March 2016.

Round 9 of the *Innovation Lab for Performing Arts* and Round 2 of the *Innovation Lab for Arts Development Agencies* will run in parallel. Proposals for both rounds of the *Innovation Lab* came from across the country – from rural communities to large cities; from small collectives to some of the largest institutions in the country.

Several strong themes across applicant proposals emerged:

- > Issues of **social justice**, **equity** and changing demographics
- Creative placemaking, community engagement, and rethinking the use of physical space
- > The intertwined relationship between local institutions and **civic ecosystems**, and the role of arts organizations in fostering change
- > How organizational structures can reflect aspects of artistic process and creativity
- > The dilemma of traditional membership organizations and what it means for the field
- > How transitional moments can act as catalysts for larger adaptive change

Ben Cameron, Program Director for the Arts at the Doris Duke Charitable Foundation, said:

"We are pleased to support these two rounds of EmcArts' *Innovation Lab for Performing Arts & Arts Development Agencies*. We hope that this combined and extended approach will have an impact not only on their individual organizations, but also on the larger fields and communities they serve."

Richard Evans, President of EmcArts, said: "We are thrilled to continue the development of our *Innovation Labs* with generous support from the Doris Duke Charitable Foundation. These eight new grantees are taking bold, honest looks at some of the critical issues facing the nonprofit arts and culture field today. The *Innovation Lab* provides formal assistance and an effective framework to support the design and testing of new strategies. Our aim is that fresh approaches and original solutions are discovered, and the work of arts organizations can contribute in new ways to the nation's cultural vitality."

Structure of the Innovation Lab

EmcArts' Innovation Labs have four phases:

Phase 1 – EmcArts works with each organization to identify a Guiding Group and Innovation Team (of up to 10 people), which then explores complex challenges, identifies possible adaptive responses, defines project goals and success measures, and conducts pertinent research.

Phase 2 – Innovation Teams from all participating organizations attend a 5-day Intensive residential Retreat that serves as a "project accelerator," giving teams time to focus on key decisions about their emerging initiatives.

Phase 3 – EmcArts grants *Lab* participants \$30,000 in change capital (plus \$9,000 in unrestricted funds) to support the prototyping and evaluation of innovative strategies before full launch.

Phase 4 – Organizations work with EmcArts to strengthen the capacities developed through prototyping, and to enroll the full organization to continuing adaptive change work.
